- Scope of Services:** Instructor hereby agrees to provide Participant **30 hours of classroom instruction, permit test and 6 hours of behind-the-wheel (BTW) instruction** designed to meet the requirements of the State of Colorado Driver's Education Program. It is anticipated, though not guaranteed, that the Program shall be completed in 60 days. **If any classes are missed, they can only be made up the next time the Session is offered and all makeup sessions must have a minimum of 8 students. Behind-the-Wheel instruction must be completed within 12 months of the Permit issue date.** Initials: _____

- Cancellation Fees:** A cancellation fee of **\$50** will be charged for any cancelation of classes or BTW lessons with less than 24 hours' notice. This fee will be collected prior to the next scheduled lesson. Fees will be collected for the following reasons:
 - If you fail to show for your scheduled lesson or class without calling to cancel at least 24 hours in advance.
 - If you forget to bring your permit or your license to your driving lesson.
 - If you show up more than 15 minutes late for your Behind-the-Wheel lesson. Initials: _____
- Code of Conduct:** Contract is for classroom instruction, the student agrees to attend, participate and not to distract or deter others from learning. If your student has behavior problems, he/she may be expelled. If your student is expelled, no refund will be given. Any damage to textbooks will be the responsibility of the student. Replacement cost of textbook will incur a \$50 charge. Cell phones or other electronic devices must be left on front desk during classroom sessions and may only be used during classroom breaks. Students must be dressed in appropriate attire; shoes, no flip-flops for BTW training. Initials: _____
